The undersigned understands that enrollment and participation in any program designed, administered, coordinated or supervised by the Mid-Atlantic Ice Dance College is voluntary and may expose me to the risk of bodily injury. I acknowledge such risk and assume full responsibility and risk for any injury or damage sustained, directly or indirectly, from enrolling and participating in any program associated with Mid-Atlantic Ice Dance College. I agree to hold the Mid-Atlantic Ice Dance College harmless from any and all claims and damages, including attorneys' fees, filed against Mid-Atlantic Ice Dance College from such enrollment and participation. I further understand and agree that Mid-Atlantic Ice Dance College is not responsible for any loss, theft or damage to my personal belongings while participating in any program and I assume full responsibility and risk for any such loss, theft or damage.

I also understand that skating on ice and other associated physical activities are physically strenuous activities and that I will be exerting myself during these programs. I acknowledge that it is my responsibility to consult with and be medically cleared by a physician prior to participating in any Mid-Atlantic Ice Dance College program.

In consideration for being allowed to enroll and participate in any program, I fully release and forever discharge the Mid-Atlantic Ice Dance College and its related entities, officers, directors, insurers, employees, instructors, and agents from any and all claims, liability and damages of any kind, known or unknown, which are related in any way to my enrollment or participation in any program, including, but not limited to claims for personal injury and damage to property. I understand and agree that the above waiver includes, but is not limited to, all medical expenses and consequential damages, including but not limited to attorneys' fees that may result from personal injury to me or damage to my property.

As a further condition of my enrollment and participation in any Mid-Atlantic Ice Dance College program, I grant Mid-Atlantic Ice Dance College irrevocable and perpetual permission to record and use my name, voice, photo, and video in which my image and likeness appears in connection with my enrollment and participation in any Mid-Atlantic Ice Dance College program.
